

Spring Program

"From Empire to Revolution: Sir James Wright and the Price of Loyalty in Georgia"

On Thursday, March 20, at 6 p.m., Greg Brooking, Ph.D., will present the Society's Spring Program, based on his book From Empire to Revolution: Sir James Wright and the Price of Loyalty in Georgia.

English-born James Wright was raised in Charleston, South Carolina, where his father served as chief justice of the colony. He followed in his father's footsteps, serving South Carolina as attorney general and colonial agent to London before beginning his tenure



as Georgia's third and final royal governor in 1761. From Empire to Revolution is the first in-depth biography of Wright, whose life Dr. Brooking uses to better understand the complex struggle for power in colonial Georgia and the wider British Empire.

Greg Brooking is a social studies teacher at North Springs High School in Atlanta. He received his Ph.D. from Georgia State University. Dr. Brooking won the 2024 Society of the Cincinnati of the State of South Carolina Fellowship to conduct research on Henry Laurens, a South Carolinian who served as president of the Continental Congress and U.S. Minister to the Netherlands during the Revolutionary War. His publications have appeared in the Georgia Historical Quarterly and General Nathanael Greene and the American Revolution in the South, among others.



May Program "Savings and Trust: The Rise and Betrayal of the Freedman's Bank"

On Thursday, May 15, at 6 p.m., Justene Hill Edwards, Ph.D., will present a lecture based on her latest book, Savings and Trust: The Rise and Betrayal of the Freedman's Bank. In the years immediately after the Civil War, tens of thousands of formerly enslaved people deposited millions of dollars into the Freedman's Bank. African Americans envisioned this new bank as a launching pad for economic growth and self-determination, but only nine years after it opened, their trust was betrayed and the Freedman's Bank collapsed. In Savings and Trust, Dr. Hill Edwards illuminates the hope with which the bank was first envisioned and demonstrates the significant setback that the sabotage of the bank caused in the fight for economic autonomy.




Justene Hill Edwards is an Associate Professor of History in the Corcoran Department of History at the University of Virginia. She received her Ph.D. in History from Princeton University. Her work investigates slavery's role in the history of economic equality in America, focusing on the 18th and 19th centuries. She is also the author of *Unfree Markets: The Slaves' Economy and the Rise of Capitalism in South Carolina*, published in 2021 by Columbia University Press. Her work has also been published in *The Washington Post*, *Business History Review*, and *Enterprise & Society*.

The program will be held at **St. Simons Presbyterian Church** at 6 p.m. It will not be recorded or live streamed. The lecture is free of charge, and registration is required by visiting coastalgeorgiahistory.org.

Georgia History Day at Oglethorpe Point Elementary School

On February 7, Allison Dupuis visited Oglethorpe Point Elementary School for the school's annual Georgia History Day. Nearly 100 fifth grade students learned about the World War II Home Front Museum and its setting in the Historic St. Simons Coast Guard Station. After discussing the Coast Guard's duties during World War II, students learned the flag semaphore, Morse code, and NATO phonetic alphabets, testing their knowledge of each by spelling words for their classmates to decode.

A Message from the Executive Director

For those of you who were unable to attend the Winter Program on January 26, I am excited to share details from the meeting including the wonderful atmosphere and the announcement of our ambitious, new strategic plan, "Preserving the Past, Shaping the Future: 2030 Vision," which will be released in full this spring.

One of the most inspiring discussions during the strategic planning process was a focus group with leaders from across the community. They saw the Society as a trusted partner and history as a powerful tool for building a stronger community. We have taken this to heart and over the next five years are eager to focus more energetically on our role as a partner, collaborator, and community resource.

In all that we do, we will be committed to working with others to deepen appreciation of our shared history.

We continue to be amazed by the centuries-long history and global significance of the Georgia Coast. The new plan directs us to expand our vision, capacity, and geographical reach to become the center for the study of Coastal history that this region deserves. This will include:

- Expanding the study of Coastal Archaeology as an essential component of understanding the past.
- Collecting important cultural and archaeological artifacts that are representative of the people who have lived here throughout history.
- Promoting research, scholarship, and quality educational experiences for all ages.
- And, sponsoring a regional conference on history, archaeology, and preservation utilizing local collaborations and generating greater community awareness of our region's remarkable history.

What will it take to become a top-notch regional research and education center?

The Society is making a significant investment in our professional staff equal to improvements that we have made over the years to programs and facilities. Therefore, I am pleased to report the addition of a staff archaeologist to our team, Aaron Ellrich. Aaron holds a Ph.D. in anthropology from the University of Florida, as well as a master's in museum studies. Aaron will ensure that archaeology is fully integrated into our educational activities and that the lab expands to serve the coastal region. With fieldwork experience in several southern states, Aaron looks forward to concentrating on our area. He will evaluate the needs of the Georgia Coast and play an important role as an expert advisor as we face climate change and disasters like the burning of the Huston House in Darien during 2024.

Last year, I announced the imminent retirement of our Curator, Mimi Rogers. We have diligently searched for the right person to fill her shoes and provide the talents and experience needed by our bold new plan. Whitney Nell Stewart assumed the role of Director of Collections & Education on February 3. Whitney is joining us from the University of Texas at Dallas where she was an associate professor of history. She has a master's and Ph.D. in history from Rice University. Whitney recently published her first book, *This is Our Home: Slavery and Struggle on Southern Plantations*, which won several awards. Aaron and Whitney are scholars and experts in their fields who see the enormous opportunity that the study of our regional history provides. It was a wonderful moment to be able to introduce them to the membership!

Lastly, I was thrilled to announce the Society's first endowed position, **The Ellen H. "Mimi" Rogers Director of Collections & Education.** The new fund will permanently recognize Mimi's unique contribution to

building our reputation for excellence and her tireless efforts in pursuit of our cause over many years. It will provide perpetual, dedicated financial support for this senior leadership position. Over the past few months, we have secured commitments of approximately \$500,000 towards our goal of \$1 million!

These are exciting times as we take intentional steps to transition and grow into a regional role. Your unfailing support over the past 15 years has provided the resources, participation, and feedback that we have needed to move forward in a purposeful way. Winter Program Recap

At the Winter Program, Nathaniel Philbrick delivered a program based on research for his book, *In the Hurricane's Eye: The Genius of George Washington and the Victory at Yorktown.* His lecture incorporated Coastal Georgia connections from his work, including the life of Nathanael Greene, a major-general in the Continental Army who later resided at Mulberry Grove Plantation outside of Savannah. Greene died at Mulberry Grove in 1786, and George Washington later visited Greene's widow, Catharine, there. Following the lecture, a reception honoring Keepers of the Light was held at The Lodge at Sea Island.
